## Mission

# Seven Hills Preparatory Academy engages students in a rigorous Classical education, designed to prepare each one for strong citizenship and life-long learning.

### Academics

Students participated in at home learning during the week of January 25th. Student attendance at the middle school was at 98% and 93% at the elementary school. Student attendance was based on student participation in their advisory or morning meeting.

Seven Hills has been chosen once again to participate in the 2022 administration of the National Assessment of Educational Progress (NAEP). NAEP is the largest nationally representative and continuing assessment of what students in the United States know and can do in various subjects. It is administered by the National Center for Education Statistics (NCES), within the U.S. Department of Education. Students in 8th grade only were selected to take the assessment on February 10, 2022, in the area of mathematics and reading.

### **School Culture**

The seventh grade students, with Ms. Hoffman in the lead, will be participating in the seventh grade overnight February 16th-February 18th. We have outgrown our former overnight program (Baker program) and will now be participating in the Deep Portage Learning Center in Hackensack, MN. Ms. Farrell as well as teachers and staff will be attending as chaperones. Covid protocols have been set in place with the help of Mr. Schlueter.
