Richfield Campus Principal's Report to the School Board

<u>Mission</u>

Seven Hills Preparatory Academy engages students in a rigorous Classical education, designed to prepare each one for strong citizenship and life-long learning.

Academics

ACCESS testing started the week of February 21, 2022. ACCESS assessments are administered to students in Kindergarten through Grade 12 for students that have been identified as English Language Learners and is given annually to monitor students' progress in learning academic English. We also had a "pop in" visit from a Test Security and Data Integrity Coordinator from the Minnesota Department of Education to observe our process.

School Culture

The seventh grade overnight to the Deep Portage Learning Center in Hackensack, MN, was a success. Students were on a full schedule and learned orienteering skills, pond measurement, and snowshoeing to name a few.

All students in grades six, seven, and eighth will be attending an all day skiing trip on March 10th at Hyland Park Reserve. Fifth grade students will be attending an all day field trip to Baker Learning Center on March, 10th, also.

The Richfield Campus will be resuming our in person assemblies starting this Friday, March 4th. The Middle School Assemblies will return to in person starting the month of April.



The Eighth grade Capstone trip to Washington, D.C. has been canceled for this school year due to restrictions for restaurant and museum entrance. Instead, the Capstone team is planning smaller field trips for the first week in June.
