# Bloomington Campus Principal's Report to the School Board Date: Thursday, March 2, 2023

Mission: Seven Hills Preparatory Academy engages students in a rigorous Classical education, designed to prepare *each one* for strong citizenship and life-long learning.

### ACADEMICS

- ACCESS testing for multi-lingual English learners finished up this month. Preliminary results aren't available until May.
- The second session of Interim Assessments in Math and Reading are in process.

#### STAFFING

- Due to increases in students receiving Special Education services, we hired a part-time (0.5)
  Speech-Language Pathologist, Lisa Rickert. We are also still looking to fill a part-time SPED teacher role.
- We have filled two long-call sub positions, Jayde Grass is currently filling the role for Taylor Ryan (EA) and Mary Topic from Strategic Staffing will fill for Jenny Dean (SLP).

#### CULTURE
