

2024-2025 Bus Transportation Guidelines

The following is an outline of SHPA's bus service transportation guidelines. These guidelines assist the school in planning and implementation of safe, efficient, and convenient bus routes for our families.

Fees

For the 2024-2025 school year the annual fee for transportation service is \$300 per child and a \$600 cap per family. This fee is non-refundable. Busing comprises a significant portion of our operating budget and we are pleased to provide quality service at a reasonable cost.

A "legacy fee" will apply to the current 2023-2024 Bloomington Campus students who reside in the city of Bloomington and will be taking SHPA transportation to the Burnsville Campus. This fee will be \$150 for a single rider and capped at \$300 for two or more students. This legacy fee will apply for the 2024-2025 school year only.

Families who have a current Educational Benefits Form on file, meet the requirements, and are approved by the state, will receive a reduced transportation fee of \$150. Educational Benefit Forms will be reviewed in the fall, and if families no longer qualify for Educational Benefits, will need to pay the fee in full at \$300.

The bus transportation fee is applicable to all families who meet any of the following criteria:

- 1. Do not live within the Burnsville Public School District #191 boundaries or Richfield School District boundaries (e.g., reside in Minneapolis, Edina, Eagan, or Lakeville, etc.)
- 2. Do not attend campus of the city in which they live (i.e., live in Burnsville, but attend the Richfield campus or vice-versa; families with children at both campuses are eligible to use the transition bus*
- 3. Live fewer than two miles from the Burnsville campus (please see MDE FAQ sheet linked below) *Transports middle school students with elementary siblings at Burnsville to Richfield and back

In order to be placed on a bus route and guaranteed service at the start of the 2024-2025 school year, all families (new and returning), must complete an online bus application form during the enrollment period from May 15th - June 14th. All families must make an online payment during the application enrollment period and pay any outstanding balance they may have from the 2023-2024 school year at that time. Late registrants will not receive a stop until the third week of the school year after initial routes have been successfully established. Single change requests may be submitted to the transportation coordinators by October 14th and changes to route stop.

Facts

- We have 20 buses that transport more than 600 students from 500 families each school day
- Safety will always be the first and foremost objective of our bus transportation service
- The goal for route times will be approximately one hour, weather and traffic permitting
- K 8th grade students who do not live in Burnsville or Richfield will be serviced by hub stops
- Burnsville/Richfield Kindergarten students will receive stops at the corner of their street
- Burnsville/Richfield 1st-5th grade students will have stops approximately 4 blocks from their house
- Burnsville/Richfield 6-8th grade students will have stops approximately 6 blocks from their house
- Parents of K-5th grade students are expected to be present at the bus stop for pickup/drop-off
- Students must be registered to ride the bus and receive only one a.m. and one p.m. stop
- Bus drivers are entrusted with the responsibility of managing and referring student behavior
- Each campuses bus service may differ in some respects based upon contracts and providers
- Students are only allowed to ride the bus to which they have been assigned (No Exceptions)

Timeline

- May 15: Busing application window opens up and building of initial routes begins
- June 14: Bus Application Deadline
- August 16: Final routes will be published
- October 14: Change Request Deadline
