ACADEMICS

- MCA testing has begun for 3rd 5th grade students (Reading & Math, Science 5th only)
- Formal observations of Teachers and EAs are nearly completed for the year.
- Conferences were held April 6th and 7th Summer School (EET) recommendations given

STAFFING
